2027 STUDY ABROAD STUDENT CONTRACT - CURRENT HONORS STUDENTS

By registering for an **Honors Study Abroad program**, I commit to making my payments on time, complying with the requirement deadlines, and remaining in the program. Refunds are not awarded. Switching programs is not allowed (refer to "Switching, Withdrawals, and Cancellations" section for more details).

Note: - IDH 4007 is the pre-travel class on campus; IDH 4008 is the class abroad.

- The Honors College enrolls students in the classes.

- Deadline dates that fall on weekends and/or holidays are **NOT** moved to the next business date.

I am aware that *in order to commit to a program*, I must (1) apply via the 2027 Honors Study Abroad application, (2) interview with the Honors College and sign this contract, (3) apply to Office of Education Abroad (OEA) application by filling out the application on abroad.fiu.edu, and (4) [pay](#) the \$500 non-refundable, non-transferrable deposit to [Student Financials or MyFIU](#) within one week after my interview.

INITIALS _____

I am aware that I do not secure a spot on an Honors Study Abroad program until I attend my group interview with the Honors College. Spaces are available on a first come, first served basis. It is recommended that I attend the first time slot available to secure a spot on my preferred program.

INITIALS _____

Documentation:

I am aware that I must upload the signed Course Registration Form to **abroad.fiu.edu specific program application** by **DECEMBER 1, 2026, 11:59PM**. If I fail to comply with the deadline, I will not be allowed to participate in IDH 4007 and/or IDH 4008, or travel with the program. Refunds will NOT be awarded. Posted charges will not be removed.

INITIALS _____

I am aware that I must upload ALL required Material Submissions to **abroad.fiu.edu** no later than **MARCH 1, 2027, 11:59PM**. Materials Submissions required by the OEA include the Medical Information Form, copy of valid passport, Pre-Departure Orientation, AlertTraveler activation attestation, and four questionnaires: (1) personal information form, (2) emergency contact form, (3) special needs form, and (4) financial information form. If I fail to comply with the deadline, I will not be allowed to participate in IDH 4007 and/or IDH 4008, or travel with the program. Refunds will NOT be awarded. Posted charges will not be removed.

INITIALS _____

I am aware that my passport must remain valid for at least six months after the last day of the program.

INITIALS _____

I am aware that if I do not have a valid passport by **MARCH 1, 2027**, I must submit proof via abroad.fiu.edu that the passport application/renewal process has been initiated by **MARCH 1, 2027**. Then, I must submit a copy of my actual valid passport no later than **APRIL 10, 2027**. If I fail to comply with the deadline, I will not be allowed to participate in IDH 4008 or travel with the program. Refunds will NOT be awarded. Posted charges will not be removed.

INITIALS _____

I am aware that depending upon the country(ies) that I am visiting and/or my country of citizenship, I may be required to apply for a visa. I understand that it is my responsibility as a participant in my education abroad program to inquire to the consular offices whether I will need to request a visa to enter the host country(ies). Immediately after being accepted, I must contact the consular offices or visit their websites for more information on my host country's entry/exit requirements and make the necessary visa appointment. The Honors College and the Office of Education Abroad are not responsible for making visa appointments for students.

INITIALS _____

I understand that if I need a letter of support from the program to apply for my visa, I may request a letter of support immediately after being accepted by visiting the Office of Education Abroad in SASC 230 or by calling (305) 348-1913. I understand that my request for a letter may take 2-3 business days to complete.

INITIALS _____

I am aware that if I identify as an International Student at FIU, I should [schedule a meeting](#) with the Office of International Student & Scholar Services to discuss my plans to study abroad prior to committing to a study abroad program by emailing iss@fiu.edu or calling 305-348-2421 (MMC) or 305-919-5813 (BBC).

INITIALS _____

Physicality:

I am aware that the completed Medical Form is valid for only six months after completion and cannot expire before the end of the program.

INITIALS _____

I am aware that if any changes are made to my medical history after the completion of the Medical Form, the changes must be documented in a memo from a licensed healthcare provider and uploaded to **abroad.fiu.edu** as soon as the change occurs. Additionally, I will notify my Faculty Director in case of any medical changes.

INITIALS _____

I am aware that the faculty leader and/or support staff do not administer medical care or provide medication. It is my responsibility to contact FIU's insurance provider via the mobile application if in need of medical care or medication.

INITIALS _____

I am aware of my dietary restrictions and needs. I have also reviewed common foods of the country(ies) I will visit on the program. I am responsible for any health or other effects due to any food that I consume while on the travel portion of the program.

INITIALS _____

I am aware that the Level of Physical Activity of the Honors Study Abroad program I am registering for. I am aware of the physical requirements of the program, and I can complete all of them.

- (1) **No exertion at all:** no walking or activities
- (2) **Easy:** limited walking, less than 10,000 steps per day, no physical activities
- (3) **Moderate:** 10,000 steps per day, few physical activities (e.g. hiking, biking, canoeing), little stairs, short-distance walking (10-15 minutes)
- (4) **Difficult:** approximately 15,000 steps per day, multiple physical activities (e.g. hiking, biking, canoeing), lots of stairs, long-distance walking (15-20 minutes)

- (5) **Extreme:** approximately 20,000+ steps per day, many physical activities (e.g. hiking, biking, canoeing), lots of stairs, long-distance walking (20-30+ minutes)

INITIALS _____

Academics:

I know that to be eligible to apply for an Honors study abroad program, I must have a minimum cumulative FIU GPA of 3.40.

INITIALS _____

I am aware that my cumulative FIU GPA will be monitored after each semester to ensure that I remain in good academic standing with the Honors College. I am aware that if my GPA falls below 3.40 after the Fall 2026 semester, I will be required to meet with my Honors College Advisor between **DECEMBER 18, 2026, AND JANUARY 21, 2027**, to create an academic improvement plan*. I will subsequently meet with my Honors College Advisor for a second time between **FEBRUARY 9, 2027, AND MARCH 15, 2027**, to discuss my academic progress toward improving my FIU GPA*.

*I will be required to email proof that the two meetings with my Academic Advisor occurred to honorsabroad@fiu.edu by **MARCH 22, 2027**.

INITIALS _____

I am aware that if my cumulative FIU GPA falls below 3.30 after the Spring 2027 semester, I will be dismissed from the study abroad program, dropped from IDH 4008, and will not be permitted to travel on the study abroad program. Refunds will NOT be awarded. Posted charges will not be removed. Any costs associated with dismissal will be my sole responsibility.

INITIALS _____

I am aware that to be enrolled in IDH 4008, or travel with the program, I must receive a grade no lower than C in IDH 4007. If I cannot be enrolled, refunds will NOT be awarded and posted charges will not be removed.

INITIALS _____

I am aware of the start and end dates of the travel portion of the program. I understand that I must be present for the **entire program**. This also implies airline ticket arrangements. Leaving early or arriving late **will** affect my grade in IDH 4008, the class abroad. No exceptions will be made to students who purchased flights based on affordability. If I earn a grade lower than a C in IDH 4008, I may be dismissed from the Honors College.

INITIALS _____

I understand that being timely and responsible are essential attributes to a study abroad program. Being tardy or absent without prior permission from my Faculty Director is disruptive to my classmates, Faculty Director, and study abroad program. Reoccurring tardiness and absences are not permitted. Tardiness and absences in the Spring and Summer courses may impact my grades in IDH 4007 and IDH 4008 and could result in dismissal from my study abroad program.

INITIALS _____

I am aware that I can enroll in a maximum of 18 credits per semester. If I want to request to enroll for 19 or more credits, I must get the [Enrollment Adjustment Form](#) signed by my Major Academic Dean's Designee, approved by OneStop, and sent to honorsabroad@fiu.edu no later than **JANUARY 10, 2027, 4:00pm** for Spring 2027 classes and **MARCH 7, 2027, 4:00pm** for Summer 2027 classes.

INITIALS _____

I understand that my Honors Study Abroad program may include a scheduled "Free Time" in which no activities are scheduled for the group. My Faculty Director has provided clear guidelines for activities and/or travel during "Free Time," and I will follow these guidelines. I will also notify my Faculty Director and/or Program Assistant of my whereabouts and give the names of persons whom I am traveling with for information purposes.

INITIALS _____

I am aware that the program's itinerary and activities are subject to change. I understand that the program's itinerary is a "*living document*," meaning that scheduled "Free Time" may be utilized for in-person quizzes, class meetings, and/or class days. I understand that I may be required to attend in-person quizzes, class meetings, and/or class days during scheduled "Free Time." I should always consult with my Faculty Director prior to scheduling plans during "Free Time."

INITIALS _____

I am aware that I must clear any existing holds on my MyFIU account and resolve any course scheduling conflicts by **DECEMBER 1, 2026, 11:59PM** and again by **APRIL 1, 2027, 11:59PM**, and I am responsible for ensuring that I have no new holds before I am enrolled in both IDH 4007* and/or IDH 4008*. I will also remain vigilant to my FIU email for any communication related to my enrollment and will work on lifting any holds that impede me from enrolling in the study abroad course(s). Failure to resolve holds will result in late registration and payment fees. If I fail to comply with removing holds by the end of the Add/Drop Period, I will not be allowed to participate in the program. Refunds will NOT be awarded. Posted charges will not be removed.

*If I have a hold on my account, I cannot be enrolled for classes.

INITIALS _____

Behavior:

I am aware that if I have been sanctioned under the FIU Student Conduct and Honor Code (<https://regulations.fiu.edu/docs=338>), which results in loss of privileges, and/or other sanctions that result in my not being considered to be in good standing with the University (e.g., conduct probation), the Dean of the Honors College will determine if I am eligible to participate in IDH 4008, travel with the program, or must return to the United States of America at my own expense. Refunds will NOT be awarded. Posted charges will not be removed.

INITIALS _____

I am aware that if I am found responsible for an Academic Misconduct Violation, the Dean of the Honors College will determine if I will be dismissed from the Honors College upon notification of findings and will not be allowed to participate in or travel with the program. Refunds will NOT be awarded. Posted charges will not be removed.

INITIALS _____

I am aware that I am expected to represent the Honors College and FIU honorably and maturely. The Faculty Director and/or staff are authorized to end my program early if my behavior becomes disruptive and/or violates the FIU Student Conduct and Honor Code.

INITIALS _____

I understand that the legal age to purchase and consume alcoholic beverages may be different in the country(ies) in which I am studying abroad. My Faculty Director has provided clear guidelines for alcohol consumption, and I will

follow these guidelines. If I do not abide by my Faculty Director's guidelines, I will be dismissed from the Honors Study Abroad program at my own expense.

INITIALS _____

I am aware that for the safety of the group, non-students, spouses, domestic partners, friends, family, and/or children are **NOT** allowed to join the travel portion of the study abroad program. I may choose to spend time with these individuals before and/or after my study abroad program.

INITIALS _____

Payments:

I understand that it is highly encouraged to make study abroad payments in-person at Student Financials (MMC: SASC 101; BBC: AC1 140) to ensure that payments are being made to the intended fees. **How to Pay:** <https://onestop.fiu.edu/finances/pay-for-tuition/how-to-pay/>.

INITIALS _____

I am aware that if I secure my spot *after* charges for an installment(s) have been posted, my missed payments will be added to the next deadline.

INITIALS _____

Study abroad fees include Program Fee (3 installments), Course Tuition, and Education Abroad Fee.

I am aware that the study abroad Program Fee is **non-refundable, non-transferrable**, and is paid in three installments: 1 week after interview (\$500 deposit), **DECEMBER 1, 2026**, and **FEBRUARY 1, 2027**. The OEA will post the charges on my account approximately 3 weeks before each payment deadline. If I fail to make them on time, the university will apply a \$100.00 late fee to my account. Late fees cannot be removed. Once the charges are posted, they cannot be removed.

INITIALS _____

I am aware that if I am paying my **Program Fee** through a scholarship or Financial Aid, it is still my responsibility to have the payments made on time and in their entirety. Therefore, it is my responsibility to contact the Office of Scholarships or Financial Aid to ensure my pending aid will be disbursed by the payment deadline and cover the full balance. If my aid/scholarship will not cover the full amount due by the deadline, it is my responsibility to pay the balance out of pocket by the deadline. If I fail to comply, I will not be enrolled in the program. Refunds will NOT be awarded. Posted charges will not be removed.

INITIALS _____

I am aware that after each **Program Fee** payment deadline there is a one-week grace period, an *extended* deadline, when payments are still accepted. However, the **late fee will still be applied, and I could get a hold on my account***. If I fail to complete my payment within exactly that *one-week* grace period, and had not notified the Honors College in advance, I will be withdrawn from the program and will not be allowed to participate in IDH 4007 and/or IDH 4008 or travel with the program, depending on the time the payment was missed. Refunds will NOT be awarded. Posted charges and late fees will not be removed.

*Students with holds on their accounts cannot be enrolled for classes.

INITIALS _____

Tuition Payments:

I am aware that if I am paying my program's **Tuition** through a scholarship or Financial Aid, it is still my responsibility to have the payments made on time and in their entirety. Therefore, it is my responsibility to contact the Office of Scholarships or Financial Aid to ensure that my pending aid will be disbursed by the tuition payment deadline and cover the full balance. If any delays are foreseen by Financial Aid, it is my responsibility to pay the balance out of pocket by **JANUARY 20, 2027, 11:59pm** for IDH 4007 and by **MAY 19, 2027, 11:59pm** for IDH 4008 in Summer A/C. If I fail to comply, I will not be allowed to participate. Refunds will NOT be awarded. Posted charges will not be removed.

INITIALS _____

I am aware that I must pay the \$195 Education Abroad Fee by **ONE WEEK AFTER MY INTERVIEW**. If I fail to comply, I will not be allowed to participate. Refunds will NOT be awarded. Posted charges will not be removed.

INITIALS _____

IF I SECURE MY SPOT ON/AFTER NOVEMBER 9, 2026:

I am aware that I must submit my signed Course Registration Form before **JANUARY 8, 2027**.

I am aware that my second and third program fee payments will be due on **FEBRUARY 1, 2027, 11:59PM**.

If I fail to comply with the dates above, I will not be allowed to participate in IDH 4007 and/or IDH 4008 or travel with the program. Refunds will NOT be awarded. Posted charges will not be removed.

INITIALS _____

Switching, Withdrawals, and Cancellations:

I am aware that once I am officially committed to the program and complete all required steps, I will be exempt from the 2026–2027 Honors College Engagement and Community Service requirements. I understand that this exemption is contingent upon my successful completion of the program. Failure to complete the program may result in the removal of my exemption, and I may be placed under a probationary period with the Honors College Engagement

program to complete the required Engagement and Community Service requirements for the 2026–2027 academic year.

INITIALS _____

I am aware that once I commit to a program, switching programs is not allowed. If I want to change programs, I will have to withdraw from the initial one, first, with no refunds. Then, I would need to secure my spot in the new program, pay the \$500 deposit again, and complete all the new program's missing payments. Permission to apply for the second program is at the Honors College's full discretion.

INITIALS _____

To withdraw from my Honors Study Abroad program, I must send an email requesting my withdrawal to my Faculty Director, Honors College Study Abroad Program Manager Nicole Patrick (npatrick@fiu.edu), and the Office of Education Abroad (edabroad@fiu.edu). I will then receive a Formal Withdrawal Form to my FIU email address via DocuSign. The form must be completed by all parties within 10 business days to process my withdrawal. Late fees will not be refunded or removed. Refunds will NOT be awarded. Posted charges will not be removed.

INITIALS _____

If my Formal Withdrawal Form is completed and processed before January 8, 2027, I may be eligible for a partial refund of posted charges. To be eligible for a partial refund of the second installment, I must locate another eligible Honors College student to take my place on the specific study abroad program that I withdrew from. The student must apply via the 2027 Honors Study Abroad application indicating that they were referred by me, (2) interview with the Honors College and sign this contract prior to January 8, 2027, (3) apply to Office of Education Abroad (OEA) application by filling out the application on abroad.fiu.edu, and (4) [pay](#) the \$500 non-refundable, non-transferrable deposit to [Student Financials or MyFIU](#) within one week after their interview. Once the new student is committed and registered for the program, I will be eligible for a partial refund of the second installment.

INITIALS _____

To request a Medical Withdrawal, I am aware that I must complete the steps to withdraw as listed above as well as provide appropriate medical documentation from a licensed healthcare professional. An approved Medical Withdrawal may be eligible for a partial refund of payments made. However, I may remain responsible for all charges if the withdrawal request is made within 90 days (about 3 months) of the start of the travel portion of the Honors Study Abroad program.

INITIALS _____

I am aware that if I am dismissed from a program for academic performance, lack of payment, lack of documentation, or due to FIU Student Conduct and Honor Code sanctions, I will still be responsible for the charges already posted to my account. That balance will still be due.

INITIALS _____

I am aware that FIU and/or the Honors College reserve the right to cancel study abroad programs—the only case in which a refund will be made. The refund will cover the program fee, including the \$500 deposit. Late fees will not be refunded or removed. I will be responsible for fees or losses incurred in canceling or changing my airfare ticket and any other expenses not covered by the program fee. Consideration to purchase Trip Cancellation insurance coverage is recommended. Refunds for the \$195 Education Abroad Fee will be at the OEA's discretion.

INITIALS _____

I am aware that FIU and the Honors College strongly discourage making big purchases, such as airline tickets, before the programs are confirmed by OEA, meaning all spots on the program are filled. If the program is canceled, FIU cannot refund these big purchases, or any other expenses related to the programs not paid directly to FIU.

INITIALS _____

I am aware that FIU and/or the Honors College reserves the right to cancel study abroad programs. If the program gets canceled once the IDH 4007 course has started, I will continue that course until it is finished. I will obtain three credit hours for it and my tuition for the course taken will not be refunded.

INITIALS _____

I am aware that by signing up to participate in a study abroad program, I am assuming all the above-mentioned responsibilities, and I am committing to complying with them without further notice.
